



This grant is to enhance and scale co-requisite model offerings for Integrated Reading and Writing classes with History, Political Science, Arts, and Academic English to meet or exceed the requirements of House Bill 2223. The proposed project supports student success by offering co-requisite models concurrently leading to successful course completion of both academic and developmental classes.

At the time of initial Board approval, the Board was informed that there was a possibility of additional funds being provided by THECB. These additional funds are being awarded to cover the remaining 25% (\$66,638) of funds requested in the application and 50% (\$108,450) for anticipated completion funding as requested in the application. Total funding from THECB for this grant will not exceed \$250,088, which includes initial funds previously authorized in the amount of \$75,000.

This Phase I Planning grant will fund 75% of the cost of engineering and architectural fees, as well as costs associated with an environmental assessment as required by the NEPA (National Environmental Policy Act) for this grant program (administered by Texas Parks and Wildlife Department). The scope of this Grant includes professional services needed to assess the feasibility of constructing the South Texas College Target Range Facility that was included in the College's Master Plan for the Regional Center for Public Safety Excellence. This includes design, engineering, and other pre-construction expenses related to state/federal environmental and cultural/historical requirements associated with the South Texas College Target Range located on 8.32 acres adjacent to El Rancho Blanco Road in Pharr. This grant has a 25% match requirement, which equals \$102,406 to be funded by South Texas College for a total of \$409,625 in funding to complete Phase I. Upon completion of Phase I and approval of required environmental compliance from the USFWS, South Texas College will be eligible for a Target Range Program grant for the construction of a 12-lane covered target range.

Respiratory Club students will promote a tobacco and e-cigarette free environment by hosting open house events including informational booths, social media promotions and flyer and banner distribution at all 5 STC campuses. 

The Pharr-San Juan-Alamo Independent School District (PSJA ISD) was awarded the Carl D. Perkins Reserve grant to implement a project entitled College and Career Regional Cybersecurity Pathway (CCRCP) in partnership with South Texas College, Hidalgo ISD, Valley View ISD, the Texas Valley Communities Foundation as the intermediary organization, and five industry/business employer partners (Frontera Consulting LLC, CODE RFG, the City of Pharr, AFT Federal Credit Union, RGV Med, LLC (dba Doctors Hospital at Renaissance (DHR), and R3ST Cyber Compliance Solutions). The goal of the CCRCP is to create, monitor, and sustain a cross-sector partnership and implement multiple exit-entrance pathways aligned to the needs of a cybersecurity workforce.

The total amount awarded to PSJA ISD for the CCRCP project is \$700,000, and STC received a sub-award in the amount of \$500,923. Approximately 75% of the funds are dedicated to equipping a Cybersecurity laboratory for courses taught at South Texas College's Regional Center for Public Safety Excellence. Thirty-five high school students will have the opportunity to earn a Cybersecurity Specialist Certificate leading to an Associate's Degree and a Bachelors of Applied Technology in Computer Information Technologies. The CCRCP project aligns to regional labor market demands and will provide work-based learning opportunities and career coaching support for students.


The purpose of this grant is to implement a 5-year project that will assist a total of 500 Migrant and Seasonal Farmworkers (MSFW) and eligible family members to obtain the equivalent of a secondary school diploma with opportunities to enroll in a post-secondary Industry Recognized Certification Career Pathway Training Program at South Texas College and to continue to complete a degree program. Funds will be used for personnel to provide oversight, coordination of the project, individualized case management support, supplies, tuition, fees, fuel allowances for HEP participants, and the external evaluation of the project.





Award Amount Increased - FY17- FY19

South Texas College has received an increasing amount of grant funds over the past three years. As shown on the bar graph below, in Fiscal Year (FY) 2017, the amount awarded was approximately \$4M. In FY2018, grants totaled to nearly \$6M, and in FY19, the amount awarded to South Texas College was approximately \$9.5M.



In addition to working to secure funding, an important initiative of our department involves cultivating relationships and expanding partnerships with other organizations that seek to accomplish similar or complementary goals. The number of awards to the college from FY18 to FY19 with external partnerships increased by thirteen percent (13%) and over half of all grant applications submitted in FY19 involved partnerships with public, private, and non-profit organizations. Many funding agencies encourage partnerships through grants, and we recognize that partnerships can be beneficial. Partner organizations often share resources and contribute to meeting project goals and objectives, which can lead to a greater impact.

One of the most important things to remember about grants is not the total dollar amount, but *the impact that those dollars have on people's lives.* Since South Texas College was founded in 1993, growth has been rapid and educational opportunities have made a tremendous impact for the residents of Hidalgo and Starr Counties. The grants that our institution has received have provided resources that support student success, the development and enhancement of academic and non-academic workforce development programs that have led to better jobs, increased wages, and new and rewarding careers for people. An increasing number of residents have attained the equivalent of a high school diploma, receive marketable skills training, industry recognized credentials, certificates and degrees through grant funded projects. Students have received scholarships, gained experience doing research, and have had opportunities to engage in work-based learning to prepare them for their chosen careers. A variety of opportunities through grants and grant partnerships have truly made a difference.

We hope that by reviewing this Annual Grant Award Report, you are encouraged by the information about grant projects and the photos that illustrate the impact that these grants have made. We are optimistic that you and others will be inspired to continue to or to get involved with grants at South Texas College.





Special thanks to all who contribute toward the continued success of South Texas College. Our collective efforts to secure external funds through grants expands the capacity of the College to achieve its mission and goals.
