

## RFA ADDENDUM No. 1 for RFA No. 781-2-24602 Perkins Basic Grant Program

Date: June 11, 2021

## **Purpose of Addendum:**

This Addendum replaces, amends, clarifies, or supplements the referenced original solicitation. Specifically, the purpose of this Addendum is: to remove the requirement to submit a program income report with the biannual and final report and to correct errata.

## **Items Changed:**

Revision:

**10.4 PROGRAM INCOME:** Removes requirement to report uses of program income with biannual and final reports

An Awarded Applicant may generate program income in the operation of projects directly supported by federal funds administered by the THECB. In no case, however, may such income be generated from fees or charges to any person or institution that is intended to be a third-party beneficiary of such projects. Awarded Applicant shall establish budget and accounting control for such program income that is separate from the project proper. This accounting shall demonstrate that the program income is being used to further the objectives of the related project. A brief narrative shall be included with biannual and final reports. The narrative shall declare the existence of program income, its source(s), the amount generated, and a brief description of the use or planned use of the funds.

## Errata:

1. **7.2 COMPREHENSIVE LOCAL NEEDS ASSESSMENT (APPENDIX F):** Corrects FY22 optional revised CLNA submission due date from July 9 to July 1.

Submission of a revised CLNA for the FY 2022 Application is optional. An institution submitting a revised CLNA for FY 2022 shall email it to <a href="mailto:Perkins@highered.texas.gov">Perkins@highered.texas.gov</a> on or before <a href="mailto:July 9">July 1</a>, 2021.

2. **7.5.2.1 Requesting Cost Items under Schedule A:** Corrects RFA reference from Section 9.32 to Section 9.43.

The Awarded Applicant shall:

- require persons paid by the Grant in whole or in part to keep Time and Effort Records. See additional information in Section 9.32 9.43 of this RFA.
- 3. **7.5.8 Schedule G: Administration/Indirect Cost:** Corrects unallowable Schedule G action from an amendment change to a charge against a \$0 budget in an expenditure report.

Applicants shall not budget \$0 for the administration/indirect budget and change this amount in a later amendment later charge administration costs against the \$0 budget in an expenditure report.

4. APPENDIX E, Certification of Compliance with Section 504 (Rehabilitation Act of 1973), ADA Title II, and Implementing Regulations: Corrects reference in Signatures warrant from FFATA to "these statutes and regulations."
